The Jack D. Gordon Public Policy Fellowship is a workforce development initiative. A highly selective program, the Public Policy Fellowship provides opportunities for students to integrate rigorous coursework, research, and mentorship in pursuit of a career in local, state, and federal government. Students will be awarded a Certificate in Public Policy Studies upon completion of program.

### *Program Eligibility*

- Minimum 3.0 GPA
- Must be an enrolled undergraduate FIU student
- Must be a U.S. Citizen or permanent resident.

### *A Completed Application Requires the Following:*

- Public Policy Fellowship Application Form
- Resume
- Cover letter indicating why applicant should be considered for the Public Policy Fellowship program (500 words max). Please specify your interest in public policy, research, and/or interest in employment with local, state or federal government.
- One letter of recommendation.

\*Program eligibility does not guarantee selection for the interview panel. Students selected for the interview panel will be based on an initial evaluation of a completed application. **The deadline to submit a completed application packet is Friday, May 4th.**
